Dear Friend and Reader:

This is the beta version of our 2021 chronology. This is primarily a timeline of news events rather than the primary source research you may be accustomed to in our **2006-2020 chronology**. It takes a while to organize this kind of document. Nearly all of it is sourced to articles collected on **Covid19 News**.

The purpose of our original timeline was to document events surrounding the claims that a new virus had been discovered, how that notion was supported, and that a PCR assay for SARS-CoV-2 had been developed. The issues went back to 2006 by one measure, and back to the claimed 1918-1919 outbreak of "influenza" by another.

What you are now reading is a document of vaccine genocide. By November 2020, there was no way to claim, even meekly, that there was still a pandemic. Of course, once you understand what happened during the prior 10 months, it's clear that there never was one. In the U.S., excess deaths were recorded in only 16 states.

And they only begin after "mitigation measures" begin in mid-March. None were recorded in Canada. If there is a contagion on the loose, it is not stopped by an imaginary line when people are crossing that line every hour of the day and night. States are political divisions, and people were killed by political decisions specific to their region.

By November 2020, even with a bogus test off-gassing nonexistent positives, the numbers coming out of Gov. Cuomo's office indicated that claimed cases and hospitalizations were so low, they would need to be reported per 100,000 people instead of per 10,000 people as they had been all year. Instead of adding decimal places to their report, the governor's office stopped sending them out.

That's when Cuomo, other governors and Canadian Mayor Justin Trudeau decided it was time to impose new lockdown measures. In New York, Cuomo ordered bars, restaurants and gymnasiums closed by 10 pm. How is it helpful to close a gym when it's empty? Well, it's helpful if you need headings and a "vaccine" is about to come out.

Sadly, the majority of our 2021 chronology documents battles between the government and the people, and between and among people, over the issue of who should be injected with an unknown mystery juice that CDC would admit had killed nearly 35,000 people by early 2023, and resulting in more than 194,000 hospitalizations and 1.5 million adverse event reports.

Events of 2021

January 1, 2021 — United States has exceeded 20 million total recorded 'covid' cases just hours after the new year. The nation has also allegedly set a 'covid' hospitalization record for four straight days. "We are still going to have our toughest and darkest days," Los Angeles Mayor Eric Garcetti told CNN. Covid Tracking Project data shows more than 125,000 'covid' patients were in U.S. hospitals on New Years Day. [CNN]

Fauci speaks to Newsweek and states "I'm sure" some individual institutions will make coronavirus vaccinations mandatory, while it is "quite possible" that the COVID-19 vaccine could become a required travel vaccine when visiting other countries. [Newsweek]

January 2, 2021 — CDC says flu numbers are down 98 percent. Possible explanations include fewer people traveling, adherence to mask-wearing and social distancing, and more Americans getting the flu shot. [NBC]

January 3, 2021 — Dormant assembly bill A-416 introduced by Assemblyman Nick Perry (D-Brooklyn) that would allow authorities to detain people suspected of being a public health threat becomes subject of conspiracy theories. The bill was first introduced in 2015 when a nurse infected with Ebola refused to quarantine. [politico]

Pope Francis says he was "pained" and "saddened" some countries reported people were going on holiday to avoid 'covid' lockdowns. In his weekly noontime Sunday address Francis said, "I read in the papers something that quite saddened me: In a country — I don't remember which — to escape the lockdown and have a good vacation more than 40 planes took off that afternoon." Fauci states he didn't expect the death toll from 'covid' to be so high in U.S. "There is no running away from the numbers," Fauci told guest host Martha Raddatz on ABC's "This Week." It's something that we absolutely have got to grasp and get our arms around and turn that, turn that inflection down by very intensive adherence to the public health measures uniformly throughout the country with no exceptions," he added. Statistics held by John Hopkins University show that 350,215 deaths have been recorded in

the United States so far, a number that has been quickly growing over the last two months. [The Hill]

January 4, 2021 — California 'covid' deaths and cases surge after holiday season gatherings and travel four times what they were during the state's summer stage. The state is facing an oxygen shortage for patients and has deployed the U.S. Army Corps of Engineers and the California Emergency Medical Services Authority to deliver and refill oxygen tanks. "This is a deadly disease, this is a deadly pandemic," Gov. Gavin Newsom told reporters. "It remains more deadly today than at any point in the history of the pandemic." Marianne Gausche-Hill, the medical director for Los Angeles County's E.M.S. agency, issued guidelines to emergency workers on Sunday for administering the "minimum amount of oxygen necessary" to keep patients' oxygen saturation level at or just above 90 percent. U.S. health officials report more than two-thirds of the 15 million covid vaccines shipped within the country have gone unused. New York and Florida governors say they will penalize hospitals that fail to dispense 'covid' shots quickly. New York Governor Andrew Cuomo states hospitals must administer vaccines within a week of receiving them or face a fine and a reduction in future supplies. "I don't want the vaccine in a fridge or a freezer, I want it in somebody's arm," the governor said. "If you're not performing this function, it does raise questions about the operating efficiency of the hospital." [reuters]

Nicholson Baker publishes "The Lab-Leak Hypothesis" in New York Magazine that investigates 'The Lab-Leak Hypothesis' and history of gain-of-function research since surprisingly, no public investigation on the origins of 'covid' has ever taken place. Baker wrote:

SARS-2 was not designed as a biological weapon. But it was, I think, designed. Many thoughtful people dismiss this notion, and they may be right. They sincerely believe that the coronavirus arose naturally, "zoonotically," from animals, without having been previously studied, or hybridized, or sluiced through cell cultures, or otherwise worked on by trained professionals. They hold that a bat, carrying a coronavirus, infected some other creature, perhaps a pangolin, and that the pangolin may have already been sick with a different coronavirus disease, and out of the conjunction and commingling of those two diseases within the pangolin, a new disease, highly infectious to humans, evolved.... There is no direct evidence for these zoonotic possibilities, just as there is no direct

evidence for an experimental mishap — no written confession, no incriminating notebook, no official accident report. [NY Magazine]

January 5, 2021 — A-416 in New York is not moving, according to Assemblyman Kevin Cahill's office. Eric Coppolino spoke with Assemblyman spokesperson who said that A-416, the medical internment camp bill is not scheduled for a vote and has not gone to committee. [Planet Waves]

North Carolina Governor Roy Cooper to mobilize National Guard to accelerate mass 'covid' vaccination rollout. The congressman was compelled to write a 600-word letter after a close friend of his passed away from 'covid'. "Our healthcare people do not need to be organizing it and doing the nuts and bolts of it. That's what our wonderful guard can do," Richardson said. [ABC]

January 6, 2021 — United States CDC says it will investigate the death of Dr. Gregory Michael who worked at Mount Sinai Medical Center in Miami Beach, Florida and died weeks after receiving the Pfizer 'covid' shot. CDC spokeswoman said the agency is aware of the reported death while Pfizer in a separate statement said it did not believe the death was vaccine related. "Our thoughts are with the family during this heartbreaking time," a CDC spokeswoman told CNN by email. "To date, more than 5 million people have received Covid-19 vaccines in the United States. CDC, FDA, and other federal agencies review Covid-19 vaccine safety monitoring data regularly and present this information to a work group of vaccine safety experts. These experts provide an independent review, as well as recommendations and guidance," she added. [CNN]

CDC publishes study that shows adverse reactions to covid vaccine with anaphylaxis is ten times higher than Flu shots, but that it is still "rare". "The anaphylaxis rate for Covid-19 vaccines may seem high compared to flu vaccines, but I want to reassure you that this is still a rare outcome," said Dr. Nancy Messonnier, the director of the CDC's National Center for Immunization and Respiratory Diseases, on a conference call to reporters. January 7, 2021 — WHO warns of covid pandemic "tipping point" as variants spread across the United States. At this time states across the country are reporting increased numbers in new strain variant, B.1.1.7. "We were prepared for a challenging start to 2021 and it has been just that", Dr. Hans Kluge, WHO Regional Director for Europe, said on Thursday during a virtual press briefing from Copenhagen. January 8, 2021 — Up to 80% of U.S. healthcare workers in some place are declining Covid-19 vaccine. The refusal is happening in nursing homes and to a lesser degree in hospitals over record speed developed shots and concerns of side effects. "I don't think anyone wants to be a guinea pig," said Dr. Stephen Noble, a 42-year-old cardiothoracic surgeon in Portland, Oregon, who is postponing getting vaccinated. "At the end of the day, as a man of science, I just want to see what the data show. And give me the full data." [KATU]

False speculative reports of a new highly contagious U.S. 'covid' variant from White House coronavirus task force member, Dr. Deborah Birx was published by multiple news outlets. The hypothetical report was sent to state governors after Birx presented graphs of escalating cases in the country at a recent meeting. "This fall/winter surge has been at nearly twice the rate of rise of cases as the spring and summer surges. This acceleration suggests there may be a USA variant that has evolved here, in addition to the UK variant that is already spreading in our communities and may be 50% more transmissible," the report read. "Aggressive mitigation must be used to match a more aggressive virus." The CDC was dismayed by Brix's report and tried to have the statements removed. [NYT]

Brisbane, Australia, the country's third-largest city locks down 2 million people after a cleaner at a quarantine hotel contracts the new U.K. 'covid' strain that officials claim is more infectious. "If we are going to stop the spread of this infectious strain, this U.K. strain, we must act immediately," Queensland Premier Annastacia Palaszczuk told media. [CBS]

January 9, 2021 — Tim Zook, an X-ray technologist at South Coast Global Medical Center in Santa Ana, dies at 60 years old, four days after receiving his second dose of the covid vaccine on January 5, 2021. A couple hours after getting the second Pfizer shot, Zook had trouble breathing and an

upset stomach. Shortly after, he was in a medically induced coma and then placed on dialysis for kidney failure and low blood pressure. [Daily News]

Dr. Ari Joffe, a specialist in pediatric infectious diseases writes a paper titled <u>COVID-19: Rethinking the Lockdown Groupthink</u> that shows how the harms of pandemic lockdowns outweigh the benefits. [<u>Toronto Sun</u>] [<u>Frontiers In Public Health</u>]

'Covid' outbreak at The Commons on St. Anthony Nursing home in Auburn, New York infects 137 residents and kills 24. The outbreak started on December 21, 2020 as a wave of post-Thanksgiving 'covid' cases hit the county, according to Julie Sheedy, an official of Loretto which operates the 300-bed nursing home. "Our team is always deeply affected by any loss of life, and our hearts are with the families of these individuals," Sheedy said. [Syracuse]

January 10, 2021 — Anti-abortion faith leaders support 'covid' vaccines given their remote and indirect connection to lines of cells from aborted fetuses. One outspoken foe of abortion based in Dallas, Southern Baptist megachurch pastor Robert Jeffress, has called the vaccines a "present from God." "To ask God for help but then refuse the vaccine makes no more sense than calling 911 when your house is on fire, but refusing to allow the firemen in," Jeffress said via email. "There is no legitimate faith-based reason for refusing to take the vaccine." [PBS]

January 11, 2021 — Superintendent of an LA school district, Austin Michael Beutner declares students must get Covid-19 vaccine when available, despite experts' concern for lack of data on teens and kids. A COVID-19 vaccine requirement would be "no different than students who are vaccinated for measles or mumps," Beutner said in a pre-recorded briefing. Beutner compares the 'covid' shot to those who "are tested for tuberculosis before they come on campus. That's the best way we know to keep all on a campus safe." [LA Times]

January 12, 2021 — CDC changes guidelines for travel that requires negative 'covid' test to all passengers entering the United States. "Testing does not eliminate all risk," says CDC Director Robert R. Redfield, MD, "but when combined with a period of staying at home and everyday precautions like wearing masks and social distancing, it can make travel safer, healthier, and more responsible by reducing spread on planes, in airports, and at destinations." January 13, 2021 — World Health Organization issues new IFU (Instructions For Use) for polymerase chain reaction testing to clarify information for In Vitro Diagnostic Medical Device (IVD) users. The notice instructs users of IVDs to carefully follow the IFU to determine if manual adjustment of the PCR positivity threshold is recommended by the manufacturer. The WHO guidance further states that careful interpretation of weak positive results is need and the cycle threshold (Ct) needed to detect virus is inversely proportional to the patient's viral load. Where test results do not correspond with the clinical presentation, a new specimen should be taken and retested using the same or different NAT technology. [WHO]

Alan Jope, the boss of one of the U.K.'s biggest companies, Unilever, states that his office workers will never return to their desks five days a week and that vaccination will not be mandatory. However, if people opt-out of inoculation they will be subjected to mandatory testing. Speaking on Wednesday at a Reuters conference, Jope said he did not expect office workers across western Europe and north America to return to work until at least April, and added that Unilever would use a "hybrid mode" of working between homes and offices after that. New York State Supreme Court Justice Henry Nowak rules in favor of restaurants suing NYS over shutting down businesses due to 'covid' by allowing them to reopen under New York State yellow zone restrictions. Tavern and restaurant owners challenged Governor Cuomo, the State Liquor Authority and the County Health Department to provide scientific proof and data that justifies the imposed restrictions initiated by the governor. "This ruling is a win for business owners and those that know the ridiculous cure of COVID closures crippling the economy is far worse than the disease. NYS must fully open businesses. Governor Cuomo and Mark Poloncarz needlessly and permanently damaged families and businesses," said Stefan Mychajliw, Erie County Comptroller [WIVB]

January 14, 2021 — President Joe Biden announces American Rescue Plan, expected to cost 1.9 trillion dollars to rollout a more robust vaccination plan and directly pay American families. The package includes \$1,400 direct stimulus checks, which would supplement the \$600 checks Congress passed late last year. Biden also proposes an additional \$160 billion for a national vaccine program, including \$20 billion for distribution, and an additional \$50 billion for expanded testing. "It's not hard to see that we are in the middle of a once-in-several generations economic crisis, with a once-in-several generations public health crisis. A crisis of deep human suffering is in plain sight," Biden said. [NPR]

January 15, 2021 — The Norwegian Medicines Agency reports in a press release that 23 nursing home patients shortly died after receiving the first Pfizer/BioNTech shot for coronavirus triggering a warning from health officials for sick patients over the age of 80 years-old. Thirteen autopsies were performed suggesting that common side effects from the vaccine likely caused the high death toll. Sigurd Hortemo, chief physician at the Norwegian Medicines Agency, said that typical reactions to the vaccine — like fever and nausea — "may have contributed to the fatal outcome in some frail patients." In result of the deaths, Norway's health officials warn the shot may be too risky for people who are suffering from severe underlying conditions over the age of 80. [Daily Mail]

United States Environmental Protection Agency announces the approval of an emergency exemption request for aerosol chemical, Grignard Pure, as an additional tool to fight against 'covid' in limited situations. The exemption has been granted to Georgia and Tennessee state governments to be used in certain indoor spaces where social distancing can be challenging. "Today, we are approving the first-ever airborne antiviral product that will help fight the spread of the novel coronavirus that causes COVID-19," said EPA Administrator Andrew Wheeler. "There is no higher priority for EPA than protecting the health and safety of Americans and I want to thank those—both within EPA and those outside—who have worked to achieve this important milestone." [EPA]

Philly fighting COVID, a startup company created by college students in Philadelphia, initiated a mass vaccination effort that sold personal data and had volunteers pocketing vaccine doses. Unsupervised 18 and 19 year-olds were administering shots to each other and posing for photos. The group switched privately from non-profit to profit status. [Washington Post]

John Hopkins University economists run a survey that suggests common public health measures such as masking, social distancing, and telework may be impractical and inaccessible for those with lower income. People who made around \$230,000 a year were as much as 54% more likely to increase these types of self-protective behaviors compared to people making about \$13,000. "We need to understand these differences because we can wring

our hands, and we can blame and shame, but in a way it doesn't matter," said Nick Papageorge, an associate professor of economics. "Policymakers just need to recognize who is going to socially distance, for how long, why, and under what circumstances to give us accurate predictions of how the disease will spread and help us establish policies that will be useful." January 16, 2021 — Fifty five Americans have died following mRNA 'covid' injections as Norway death toll rises to 29. The report prompts Norway to suggest the experimental injections maybe too risky for the elderly and terminal ill. Pfizer and BioNTech are working with the Norwegian regulator to investigate the deaths in Norway, Pfizer said in an e-mailed statement. The agency found that "the number of incidents so far is not alarming, and in line with expectations," Pfizer said. [Health Impact News]

Medical groups of doctors and nurses including the British Medical Association, Medical Protection Society, and Doctors' Association UK write to ministers asking for protection over unlawful killing charges where 'covid' treatment decisions are made under the pressures of the pandemic. The health organizations point out the warning from the prime minister in November that the NHS being overwhelmed would be a "medical and moral disaster", where "doctors and nurses could be forced to choose which patients to treat, who would live and who would die". The letter also stated: "With the chief medical officers now determining that there is a material risk of the NHS being overwhelmed within weeks, our members are worried that not only do they face being put in this position but also that they could subsequently be vulnerable to a criminal investigation by the police. January 17, 2021 — American Airlines expands access to the first U.S. digital health passport system called "VeriFLY", that confirms testing and other travel restrictions. According to a press release seen by Simple Flying, American Airlines VP of customer experience Julie Rath shares that her company is expanding the usage of the app to make international travel easier for its customers. The application allows flier to enter their destination and upload required documentation such as proof of a negative PCR test. "We've had the guidance of medical experts as we worked through our procedures. We work very closely with Vanderbilt University Medical Center. This is definitely not the time to ask Dr. Google what to do. So, we felt very fortunate to have their guidance as we worked through these procedures. And we also worked with other organizations, such as the Global Biorisk Advisory Council, to make sure that everything that we're doing is the gold

standard of clean and safe," said Clarissa Sebastian, managing director of premium guest experiences and onboard products at American Airlines.

January 18, 2021 — Israel strikes deal with Pfizer that promises to trade vasts amount of medical data in exchange for hard-to-get covid vaccines. Critics say the deal raises major ethical concerns, including possible privacy violations and a deepening of the global divide that enables wealthy countries to stockpile vaccines. Israeli Health Minister Yuli Edelstein told The Associated Press the government will turn over data to "see how it influences, first of all, the level of the disease in Israel, the possibility to open the economy, different aspects of social life, and whether there are any effects of the vaccination." Beverly Hills doctor and open critic of coronavirus vaccines, Simone Gold arrested in connection with capital riots. Gold garnered national attention when she organized a press conference outside U.S. Supreme Court condemning mandatory pandemic lockdowns and advocating for "hydroxycholorquine" as a 'covid' treatment. [Yahoo]

January 19, 2021 — Van Morrison pursues legal action over Northern Ireland's 'covid' ban on live music in licensed venues. Van Morrison will ask high court in Belfast to review the 'covid' restrictions policy. "We will be seeking leave for judicial review to challenge the blanket ban on live music in licensed premises in Northern Ireland," Rice said. "We're not aware of any credible scientific or medical evidence to justify this particular blanket ban ... and we're going to challenge this in the high court," said solicitor Joe Rice. January 20, 2021 — China rushes to build massive covid quarantine camps to fit 4,000 people during recent covid outbreak. The camp is located on the outskirts of Shijiazhuang, the provincial capital of Hebei province, which surrounds the country's capital, Beijing. Officials in Shijiazhuang, where the outbreak is centered, have initiated mass testing and strict lockdowns, moving entire villages into centralized quarantine facilities in a bid to curb the spread of the virus. The camp will also house close contacts of confirmed covid patients. [CNN]

Sleep experts recommend prioritizing sleep before getting a covid inoculation to achieve a better immune response. An article was published in Health Day News where several studies were cited to have found an association between sleep and vaccination response. "As COVID-19 vaccines are being distributed, it is of utmost importance that patients continue to prioritize their sleep to maintain optimal health," American Academy of Sleep Medicine (AASM) president Dr. Kannan Ramar said in an academy news release. "Getting sufficient, high-quality sleep on a regular basis strengthens your body's immune system and optimizes your response to a vaccine." [Health Day News]

Biden administration signs executive order to protect Federal workforce by requiring masks be worn. Section 7902(c) of title 5, United States Code, hereby orders based on the best available data and science-based public health measure to wear masks and social distance. Stated in section 1 to protect Federal workforce and individuals interacting with the Federal workforce to ensure the continuity of Government service and activities, individuals should all wear masks, and adhere to other public health measures, as provided in CDC guidelines.

January 21, 2021 — CDC stops reporting new data on experimental mRNA injection side effects. The agency claims there is no new data on the new experimental mRNA inoculations. At this point, deaths and adverse reactions are being reported all throughout the United States and yet no investigation is happening as to why? The last report on the experimental injections and the adverse side effects was from January 6, 2021, and only covered the first week of injections with the experimental Pfizer COVID mRNA shots, with an emphasis on allergic reactions and anaphylaxis shock. The report on January 6th did not cover the Moderna injections which have also received emergency use authorization by the FDA.*See January 16, 2021 entry. [Health Impact News]

Amazon offers to help newly elect President Joe Biden inoculate 100 million Americans during the first 100 days of presidency. "Our scale allows us to make a meaningful impact immediately in the fight against COVID-19, and we stand ready to assist you in this effort," wrote Amazon Worldwide Consumer CEO Dave Clark in a letter to Biden. Clark also wrote an initiative to vaccinate Amazon employees. "The essential employees working at Amazon fulfillment centers, AWS data centers, and Whole Foods Market

stores across the country who cannot work from home should receive the COVID-19 vaccine at the earliest appropriate time," wrote Clark. [USA Today]

January 22, 2021 — CDC releases new VAERS data of 329 reported deaths, 285 were from the U.S., and 44 were from other countries. The average age of those who died was 76.5. The 329 deaths are included in the 9,515 injuries reported as of this date. [CHD]

Home run king, Hank Aaron dies at 86-years old from 'undisclosed cause', roughly two weeks after receiving the Moderna covid vaccine. Aaron made headlines earlier in the month when he photographed getting the Moderna vaccine. He told the Associated Press that getting vaccinated "makes me feel wonderful." "I don't have any qualms about it at all, you know. I feel quite proud of myself for doing something like this. It's just a small thing that can help zillions of people in this country," said Aaron [CHD]

January 24, 2021 — Hanson Robotics, the makers of Sophia a humanoid robot, based in Hong Kong, say four models, including Sophia, would start rolling out of factories in the first half of 2021. The company's researchers predict the pandemic will open new opportunities for the robotics industry. [reuters]

The New York Times runs an article titled, Why Vaccines Alone Will Not End the Pandemic. It states a new model by scientists at Columbia University that millions more people will still be infected and become ill if they do not wear masks and maintain social distancing. Dr. Jeffrey Shaman, an epidemiologist at Columbia estimates that more than 105 million people have already been infected across the U.S., well above the number of cases that have been reported. And his projections show millions more infections are yet to come as the vaccine rolls out. "There are people who are going to want to relax the controls we have in place," Dr. Shaman said. "If we start thinking, 'We've got a vaccine, there's a light at the end of the tunnel, we can stop in a couple of months' — that's way too soon." [NYT]

Editor's Note: Public health policy releases and the discussion of math modeling in the media continue to suggest — **without scientific evidence**

All this is suggested as true, even though organized, reproducible research has yet to be done to prove the efficacy of masking and lockdowns, and to answer the question of whether the experimental mRNA biologics can actually succeed in anything *other* than the previously observed "reduction of symptoms" in those affected by the disease process named covid-19.

It should not come as a surprise that Pfizer, one of the manufacturers of the experimental mRNA technology, has funded part of the effort to communicate this fuzzy science.

What should be quite shocking, however, is just how unrestrained is **the** spread of this particular non-fact of vaccine-conferred immunity.

It is never stated overtly, but it is regularly implied in missives from wideranging sources such as Rite Aid emails, NYS PSAs and in articles from the NYT. That these suggestions of any benefit beyond the reduction of symptoms are based on old data, gathered from the widespread use of fundamentally different biologic agents, against different pathogens — and all under the shadow of continued debate regarding the foundational assumptions of germ theory and virology as a whole — is not stated, either.

Rather, we see a suddenly sloppy application of old assumptions creeping in and being applied to the unobserved, and only mathematically described, novel virus.

Even with the debatable assumption that the genomic sequencing data on the pathogen is in any way an accurate place to start, there is no rational scientific reason to have it both ways: first, that novel viruses need new public policy and new tech to combat them; and also that old virology and related vaccine results apply by inference.

It is also interesting to note how often, and where, science professionals are acceptably quoted as using phrases like "gut check" and "intuitive sense" when being asked about the truth of such novel math modeling — which is predicting the future while depending only on debatable data from the past.

Current pressures inviting centralized "fact-checking" and censorship of "false information" which "goes against science" would seem to require statements be made from, and be based on, some foundation other than a "qut" sense. — efc

We found that the drug plitidepsin (aplidin), which has limited clinical approval, possesses antiviral activity (90% inhibitory concentration = 0.88 nM) that is more potent than remdesivir against SARS-CoV-2 in vitro by a factor of 27.5, with limited toxicity in cell culture. February 25, 2021 — Moderna reports it has begun experimental testing on a new 'covid' vaccine designed to target deadly South African variant. The batch was shipped to the National Institute of Health (NIH) to begin human trials. Reports glorify the use of mRNA technology that allows scientists to modify and design drugs "on the fly". [Futurism]

European leaders begin debate over vaccine passports that would allow inoculated people to travel during busy lucrative travel seasons. 

March 7, 2021 — The family of Drene Keyes, a 58-year-old Gloucester resident who died following a Pfizer shot had a private autopsy performed by her relatives investigating her death since the state of Virginia would not pay for it.

Roger Chesley, a reporter for the Virginia Mercury, published a follow up commentary on March 12, 2021 claiming the Virgina Virginia Health Commissioner Dr. Norman Oliver assured him the death of Drene Keyes was properly investigated by the state — even if there wasn't a full autopsy, but apparently one was performed.

An assistant medical examiner said the office tested for elevated tryptase levels, which can be higher when someone has died from anaphylaxis or a severe allergic reaction. Results showed near normal levels and the state in result determined the cause of death was due to 'covid' complications and underlying health conditions such as a hyptertensive cardiovascular disease, obesity and diabetes which they wondered if Keyes even knew about.

Interestingly enough, Keyes's daughter Lisa Jones said the preliminary autopsy results were negative for 'covid'. The Virginian Pilot also notes the public records request it filed regarding the cause of death concerned state

officials since Keyes was black which could make it tougher to vaccinate minorities who were already hesitant to get the shot.

March 11, 2021 — Canada says the AstraZeneca shot is safe after Denmark and Norway suspend use after reports of blood clots.

"Health Canada is aware of reports of adverse events in Europe following immunization with the AstraZeneca COVID-19 vaccine, and would like to reassure Canadians that the benefits of the vaccine continue to outweigh its risks," the health department said in a statement.

On July 5, 2022 it was announced Canada will throw out 13.6 million doses of AstraZeneca since there are no takers and demand of the controversial experimental drug. Regardless of causing blood clots, the country managed to inoculate 2.3 million Canadians with at least one shot. Even though in July 2021 Canada promised to donate the rest of its supply, roughly 17.7 million doses, they will still have to throw away due to expired products. [The Guardian] [Reuters]

March 9, 2021 — Australian health minister Greg Hunt was admitted to the hospital with a suspected infection two days after receiving AstraZeneca Plc's 'covid' vaccine.

A couple months later on May 19, 2021, Greg Hunt makes comments on ABC that anyone uncertain about the AstraZeneca shot, there will be enough of Pfizer's mRNA shots to go around. "Right now, we want to encourage everybody over 50 to be vaccinated as early as possible," Hunt told ABC News Breakfast on Thursday.

The comment caused confusion among Australians over whether they should wait to be inoculated or just go ahead and get jabbed regardless of their blood clot concerns. Dr. Omar Khorshid of The Australian Medical Association [AMA] clarifies Hunt's comments by stating that the message has always been to not wait and to get vaccinated right away.

Khorshid comments that Greg Hunt should have mentioned that if people over 70 years-old refuse AstraZeneca shots they will then be waiting until the end of the year for a replacement jab. In other words, take a chance with your life and get blood clots now or wait for another shot to potentially give you blood clots and myocarditis later.

World Health Organization approves Emergency Use Authorization of the Johnson and Johnson covid vaccine. The authorization allows J&J to make their shot eligible for distribution in low-and-middle income countries through Covax. The J&J shot can be stored for three months at refrigerator temperatures which makes it well suited for countries and locations that may not have access to freezers and ultra-cold storage units. "As new vaccines become available, we must ensure they become part of the global solution and not another reason some countries and people are left further behind," Dr. Tedros Adhanom Ghebreyesus, the director general of the W.H.O., said in a briefing. [The New York Times]

March 14, 2021 — Health officials in Northern Ireland continue to use Oxford-AstraZeneca shot despite its suspension in the Republic of Ireland due to induced blood clot side effects. Ireland's Health Minister Stephen Donnelly said it's "precautionary". Chair of the British Medical Association NI's GP committee, Dr Alan Stout, said it was important that anyone with a vaccine appointment scheduled attends it as planned. "We are confident that the vaccine is extremely safe to use and it is one of the key facets of our fight against Covid-19," he said. [BBC]

South Africa's decline in 'covid' cases becomes a mysterious phenomenon. "These include universal and correct use of masks, physical distancing, hand washing and respiratory etiquette, cleaning to maintain healthy facilities and diagnostic testing with rapid and efficient contact tracing in combination with isolation in quarantine and in collaboration with local health departments," said CDC Director Dr. Rochelle Walensky during a White House Covid briefing. [CNN]

Georgia's health ministry to limit AstraZeneca use after a 27-year-old nurse dies from anaphylactic shock. Director of Georgia's National Centre for Disease Control, Amiran Gamkrelidze described the nurse's condition as serious and states, ""Our 27-year-old colleague suffered anaphylactic shock after vaccination with the AstraZeneca vaccine and was transported to an intensive care unit in Tbilisi," Gamkrelidze was quoted as saying. [Reuters]

Scientists from across the world believe 'covid' is causing diabetes. Professor Francesco Rubino from King's College London leads a full investigation into the possible covid and diabetes link after seeing a rise in both type 1 and type 2 cases. Doctors even consider the possibility of covid inducing an entirely new form of diabetes. "Over the last few months, we've seen more cases of patients that had either developed diabetes during the Covid-19 experience, or shortly after that. We are now starting to think the link is probably true – there is an ability of the virus to cause a malfunctioning of sugar metabolism," said Rubino. If there was a biological link, it would be difficult to prove without a substantial database, he noted. "We said it's

worth embarking on an investigation because this – especially given the size of the pandemic – could be a significant problem." [The Guardian]

A professor in charge of leading a full investigation into the possible covid virus and diabetes link even admits it would be difficult to prove. As U.S. schools continue to shutdown and move to remote learning, more parents take note of declining mental health among children. 



March 25, 2021 — An unprecedented low amount of flu cases of flu is reported. Hospitalization rate for the 2020-21 flu season was just 0.7 per 100,000 people, the lowest it's been since the Centers for Disease Control and Prevention began collecting such data in 2005. Public health officials are relieved to have avoided a "twindemic" but are concerned about flu vaccine efficacy next winter due to a smaller pool of data. [Politico]

Pfizer and German partner BioNTech begins pediatric testing of the experimental covid shot in children under 12 years. The safety test plan is to inoculate twice the 144-participants in Phase I/II trials with three different dosages of 10, 20 and 30 micrograms. They plan to later expand to a 4,500-participant late-stage trial in which they will test the safety, tolerability and immune response generated by the vaccine, likely by measuring antibody levels in the young subjects. [Reuters]

Rutgers University announces it will require all 71,000 students to be inoculated with 'covid' shots in order to attend classes in the fall. When asked about the legality of mandating experimental shots that have not been fully FDA approved, a spokesperson for the university stated, ""The University is comfortable with the legal authority supporting this policy, which has been thoroughly reviewed by our Office of General Counsel." Students would be given the option to apply for religious and medical exemptions and online only students would not need to be vaccinated. [NBC Philadelphia]

March 26, 2021 — Britain authorizes a 20 second 'covid' test to be used in airports, sports venues and businesses. Prime Minister Boris Johnson claims rapid tests could be the key out of lockdowns, but major concerns over the accuracy of existing lateral flow devices are expressed. The Virolens test was made by a British start-up iAbraand TT Electronics that was piloted at Heathrow Airport and is based on collecting saliva swabs. [Reuters]

Amazon receives FDA authorization of its at-home covid test developed by subsidiary STS Lab Holdco. The test is to be used on workers as apart of their "covid preparedness and response program". CNBC reported in June that Amazon built a dedicated team to develop coronavirus testing capacity, assigning research scientists, program managers, procurement specialists and software engineers to support the effort. The company also launched standalone diagnostic labs in Sunnyvale, California, and in Hebron, Kentucky. [CNBC]

A few weeks after Texas reopens without covid mandates, health officials start investigation on the impact of no restrictions. While the state did not see any rise in 'covid' cases, officials claim it is "too early to tell". [WSJ]

March 27, 2021 — 'Covid' inoculation and verification if based on the Corman-Drosten RT-PCR will yield about 50 percent false positives when a maximum of 35 cycles are applied. If only 25 cycles are applied the fraction of false positives drops to 20%. [Off Guardian]

New study will track covid vaccinated college students and their close contacts to see if they can transmit the disease to other people. Researchers will use the data to determine just how careful inoculated people need to be and whether or not they can throw away their masks and end social distancing. [NYT]

March 28, 2021 — Biden administration continues to work with private companies on the development of establishing a system for Americans to prove their 'vaccine credentials'. According to U.S. officials they are struggling with an array of challenges such as data privacy and health-care equity. The administration's initiative has been largely handled by The Department of Health and Human Services, including an office branch that works solely on health information technology. March 29, 2021 — Canada's National Advisory Committee on Immunization (NACI) recommends that provinces stop inoculating people under the age of 55 years with AstraZeneca-Oxford covid vaccine due to rising cases of blood clots in Europe, notably among younger women. The European Union's drug watchdog, the European Medicines Agency, has said it could not definitively rule out a link between the vaccine and rare types of blood clots associated with thrombocytopenia. Major League Baseball says it will relax 'covid' prevention measures when 85 percent of the players are vaccinated. At this time, not many of the players had been vaccinated, but according to the MLB it expected more to be after returning home from spring training. [AP News]

White House says it would not issue a federal vaccine mandate requiring everyone to be vaccinated, but would instead leave the private sector to take lead on verification of 'covid' vaccines or vaccine passports. The Biden administration was reviewing the issue and would make recommendations,

White House press secretary Jen Psaki said on Monday, but she added, "We believe it will be driven by the private sector." [reuters]

New York judge rules that all incarcerated people in the state's prisons and jails must receive the covid vaccine. The order came after claims the coronavirus continues to spread rapidly through facilities with at least 1,100 testing positive for covid since the start of the pandemic and 5 dying. [New York Times]

Biden administration urges governors to re-instate mask mandates while CDC director, Rochelle Walensky warns of "impending doom". Walensky pleads with American people to "hold on a little longer" and continue following public health advice, like <u>wearing masks</u> and social distancing, to curb the virus's spread. [NYT]

March 30, 2021 — White House urges WHO to investigate further the origins of 'covid' after recent reports failed to meet U.S. and its allies expectations.

"There's a second stage in this process that we believe should be led by international and independent experts. They should have unfettered access to data. They should be able to ask questions of people who are on the ground at this point in time, and that's a step the WHO could take," White House press secretary Jen Psaki told reporters. [reuters]

U.S. based human rights lawyer breaks down the contradictions of vax "efficacy" by FDA, CDC, and NIH in addition to incomplete studies that show no proof 'covid' shots prevent infection or transmission. There is no legally substantiated ground to mandate an entire population receive an experimental drug. [Off Guardian]

March Summary — Editor's Note: March is a lot of setting the stage for future medical mandates. U.S. government states they won't mandate vaccine passports, but doesn't mean the federal government won't assist private entities to develop standards for equity and private that programs need to uphold. April 6, 2021 — President Joe Biden says all U.S. adults should be eligible to receive 'covid' shots by April 19, a new deadline to expand eligibility two weeks earlier than originally planned. April 24, 2021 — Thousands of mostly maskless people gather in Hyde Park London apart of a Unite for Freedom protest against vaccine passports and all forced medical mandates. Some reports put the crowd size at

10,000. One marcher carried a sign reading "They did not isolate a virus. They isolated you." Others said "No to vaccine passports" and "Lockdowns kill."

Drone footage captured the crowded streets that clearly displayed more than a scant couple thousand people were present. West Virginia bribes young people with one hundred dollar incentives to receive experimental 'covid' drug inoculations. 

The Brit Awards take place as part of the government's live events pilot scheme and is the first largest indoor music event of the year. An audience of 4,000 people were present in the O2 Arena where no social distancing and masking requirements were enforced. No cases of 'covid' emerged.

May 18, 2021 — Hospital Pediatrics publishes two research papers indicating the reported number of 'covid' hospitalizations in California hospitals was overcounted by at least 40 percent. The tracking system was one of the primary metrics used for measuring the severity of the 'covid' pandemic. [New York Magazine]

The European Union agreed a reopening of its borders only to fully vaccinated visitors with an approved shot from a list of countries considered 'safe'. Ambassadors from 27 member states endorsed the plan allowing non-essential travelers and tourists to enter just in time for tourist season. [The New York Times]

May 19, 2021 — Three deaths attributed to the 'covid' injections were reported in Scotland. So called Public health expert, Professor Linda Bauld at the University of Edinburgh told BBC Scotland that serious adverse effects were extremely unusual. Meanwhile she mentions the expert public expert group she is apart of is aware of the blood clots caused by Oxford-AstraZeneca shots and there may be other "contributing factors". Food and Drug Administration advises against the use of SARS-CoV-1 Antibody test results to evaluate immunity or protection from 'covid-'19. May 20, 2021 — A 'covid' guidance report tweak was issued by UK Government officials stating 22 million fully vaccinated Brits may still need to isolate for 10 days after coming in close contact with someone infected with 'covid' after June 21. The guidance — which is not a law, was made without an official announcement which prompted criticism from MP's. Government sources told Metro UK that the contact tracing system should be here to stay, as there is a risk of catching and spreading 'covid' even after both jabs. [Metro UK]

May 21, 2021 — Details from an internal CDC report obtained by NPR under the Freedom of Information Act, explores why the agency's original 'covid' test kits failed. In February 2020, initial tests sent to the nation's labs were coming back "inconclusive" due to "inadequate document control", meaning there were various versions of instructions and protocols in labs. [NPR]

Pennsylvania drops two lawsuits filed in Commonwealth Court on December 23 and January 5 against 46 restaurants that stayed open during a three-week winter holiday ban on indoor dining. The draconian measures enforced by the state sought money the restaurants made by keeping their businesses running in addition to any "punitive damages for the willful and wanton violation of the orders. A petition to drop the threats from abusive government power heads was signed by Pennsylvania residents with a mention of a decline in new 'covid' cases and hospitalizations'.

<u>Note:</u> U.S. District Judge William Stickman IV ruled in favor of plaintiffs in September 2020 that Gov. Tom Wolf's pandemic restrictions that mandated people stay home, place limits on social gatherings were unconstitutional.

"The Constitution cannot accept the concept of a 'new normal' where the basic liberties of the people can be subordinated to open-ended emergency mitigation measures." — U.S. District Judge William Stickman IV.

Evolutionary biologist, Sebastien Calvignac-Spencer lead a study with colleagues at the Robert Koch Institute in Berlin, Germany's federal disease control and prevention agency and found the six human lungs that dated to the pandemic years of 1918 and 1919 had confirmed the virus had mutated. Researchers found three of the six lungs, preserved in formalin in pathology archives in Germany and Austria contained the 1918 influenza virus. [Live Science]

Facebook changes policy of censoring 'covid' as a man-made disease by acknowledging the renewed debate on its origin. The tweak in policy comes as White House officials prompt further investigations into the Wuhan Lab

where three scientists allegedly fell ill and were hospitalized in late 2019 with symptoms of the virus. Biden announced he ordered the intelligence community to "redouble" its investigative efforts and report back in 90 days. Biden stated the intelligence community is split between two opposing speculations as to where the virus originated. One side believing it was of natural origin and the other lab made. [Politico]

New York Gov. Andrew M. Cuomo jumps on bandwagon of bribing young adults to get injected with experimental 'covid' drug shots. The incentive for getting inoculated is any state resident between the ages of 12 and 17 who gets first dose of Pfizer-BioNTech shot would be entered into a raffle to wine a full-ride scholarship to a New York public university. The incentive comes due to a decline in state vaccination rate and young people feeling they do not need the injection. [NYT]

May 27, 2021 — The Wall Street Journal reports that more than a hundred pregnant women are dying from 'covid' every month in Brazil, which is more than twice the rate from the previous year. Researchers blame the P.1. 'covid' variant that first appeared in the Amazon despite there being no isolate of a covid virus to be tested for using PCR. Allegedly, the P.1 variant overwhelmed hospitals and more than 800 expectant and postpartum mothers in Brazil died from the disease since start of pandemic. [WSJ]

California launches largest U.S. 'covid' inoculation incentive program offering 10 residents the chance to win \$1.5 million dollars each. Thirty additional inoculated Californians will also win awards of \$50,000 and will be automatically entered into drawings with no need to register, according the state officials. The \$116.5 million dollars amounts to roughly three times as much as Newson's budget to spend on surge capacity for the California Department of Forestry and Fire Protection during wildfire season and far more than the budget's \$3 million dollar plan to study the needs of public health department, even as the agencies insist their needs are well known. [LA Times]

Cases of respiratory syncytial virus or RSV are continuing to increase despite having ironically disappeared during onset of 'covid' pandemic. RSV in the past usually puts nearly 60,000 children under age 5 in the hospital, but has been nonexistent. Despite not having isolated actual virus particles to test, computational biologist Trevor Bedford at the Fred Hutchinson Cancer Research Center in Seattle claims to be monitoring viruses circulating through Nexstrain, a program that tracks the genetic evolution of pathogens. [STAT News]

May 28, 2021 — One hundred and seventeen employees at Houston Methodist Hospital in Texas sue over 'covid' vaccine mandates. The lawsuit was filed in Montgomery County with allegations the hospital is "illegally requiring its employees to be injected with an experimental vaccine as a condition of employment". A violation of the Nuremberg Code's medical ethics was also cited in the complaint. Attorney Jared Woodfill who filed lawsuit, told ABC News that hospital is forcing employees to get injected to boost the hospital's profits. [ABC News]

Update: **On June 12, 2021,** U.S. District Federal Judge, Lynn Hughes dismissed the case in a five page ruling upholding the hospital's vaccine mandate policy, citing the requirement did not break the law. In response to the plaintiffs complaint over violating Nuremberg Code's medical ethics, Hughes stated, "Equating the injection requirement to medical experimentation in concentration camps is reprehensible. Nazi doctors conducted medical experiments on victims that caused pain, mutilation, permanent disability, and in many cases, death."

***NOTE: At the writing of this entry on September 12, 2022 there have been 1.4 million reports of adverse reactions to 'covid' shots and 30,796 deaths attributed to the inoculation. [NPR] [VAERS]

New Jersey lifts indoor mask mandates just in time for summer gatherings at the Jersey shore. The move follows the recent CDC guidelines that fully vaccinated people can remove their masks in and outside. Governor Phil Murphy urges vaccinated people still waiting for two weeks to pass since second Pfizer and Moderna shots or one shot J&J inoculation to still wear masks. Despite lifting indoor mask mandates and putting "responsibility of masking on individuals", the state upholds mask mandates in public schools, health care settings, correctional facilities, homeless shelters, warehousing and manufacturing, and public transit hubs. [NBC]

May 30, 2021 — Britain announces a plan to drop 'covid' passports as a legal requirement for large events. The reveal comes after officials reviewed the 'covid' status certificates and believed there was no chance the law could be changed to mandate use. The UK's Conservative party and civil rights groups voice major ethical concerns over the mandates. [Reuters]

June 1, 2021 — Moderna applies for full approval to U.S. Food and Drug Administration for the use of its covid shots in people 18 years and older. "We look forward to working with the F.D.A. and will continue to submit data from our Phase 3 study and complete the rolling submission, Stéphane

Bancel, Moderna's chief executive, said in a statement. [The New York Times]

China reports the first diagnosed human case of H10N3 bird flu found in a 41 year old man in the eastern province of Jiangsu. The alleged infection was confirmed as the first human case of this rare strain said Beijing's National Health Commission (NHC). Many different strains of bird flu are said to exist in China that sporadically infect people, usually working with poultry. The World Health Organization (WHO) replies acknowledging the source of the patient's exposure to the H10N3 virus has not been confirmed and no other cases were found in emergency surveillance among the local population. No indication of human-to-human transmission exists. [Reuters]

June 2, 2021 — "Get a shot, have a beer" says President Biden as a way to reach July vaccination goal. The president praised Anheuser-Busch for giving away a beer if adults over the age of 21 receive the experimental drug. Other incentive initiatives to vaccinate the country include free childcare for individuals who get jabbed and working with barbershops and beauty salons with Black owners and clientele to encourage shots. [Reuters] [White House]

June 3, 2021 — Former CDC Director Robert Redfield received death threats for supporting the 'covid' lab leak theory, according to a recent Vanity Fair interview. Redfield says he received threats from other prominent scientist when he publicly stated he believed the virus most likely leaked from a lab and not from natural origins. His beliefs came at a time when President Joe Biden had even called on the intelligence community to "redouble" investigation into virus's origin after three Wuhan Lab scientists were hospitalized for 'covid' symptoms. Dr. Anthony Fauci admits in a CNN interview that he still believes 'covid' came from natural origins despite the exposed email which shows his relationship to EcoHealth Alliance who funded the Wuhan Lab research. Questions over Fauci's conflict of interest rise when an EcoHealth alliance executive thanks him for stating his belief in natural origins opposed to lab. [CNN]

June 4, 2021 — Scientists are reporting the 'covid' pandemic may have killed off two common strains of the seasonal flu, most likely due to adhering to mask mandates and following 'covid' prevention protocols. Apparently, the two viruses seemed to have vanished from the face of existence ever since 'covid' appeared. The global monitoring of the evolution of flu viruses comes from testing samples of confirmed flu cases in people. However, since March

2020 scientists say they haven't detected traces of two common flu strains: influenza B viruses belonging to the Yamagata lineage and a clade of the influenza A H3N2 virus, known as 3c3. [Gizmodo]

CDC urges parents to get their teens inoculated with covid shots amid rising hospital cases in March and April. Director Rochelle Walensky promotes the shots as the best way to protect their children from a severe disease. The data for this study is based on CDC's own covid associated surveillance network which is a system of laboratory-confirmed covid hospitalizations in 99 countries across 14 states, covering only 10 percent of the U.S. population. June 7, 2021 — New York Governor Andrew M. Cuomo announces a lift of most 'covid' limits on businesses and social settings, but only after 70 percent of adults have received at least one 'covid' drug injection. The governor states reaching the threshold would enable an end to restrictions such as social distancing, capacity limits and disinfection protocols and health screenings.

June 15, 2021 — Nearly 900 expired 'covid' doses are administered at a New York City clinic. The recipients were advised to get jabbed again since the Pfizer vax may not work against protecting from the virus. June 17, 2021 — 'Springsteen On Broadway' bans fans who have not received an FDA "approved" vaccine such as AstraZeneca although at the time of the announcement none of the jabs have been fully approved and are issued for 'Emergency Use'. Important to note that the original publishing of this announcement stated "approved" and the language was later changed to "authorized" without mention of correction by editors. [Deadline]

June 20, 2021 — Foo Fighters lead the way with the first-ever vaccine mandate at Madison Square Garden.



The venue requires all attendees be inoculated for covid and to provide proof before entering the arena. Eric Francis Coppolino of Planet Waves interviews people waiting on line about how they feel about the mandate and is it necessary. Protesters opposing the vaccine only show rally outside with signs reading "no health passports" and "I choose

India's mucormycosis or black fungus epidemic shoots up to more than 30,000 from negligible levels in just three weeks. Former covid patients across the country have been sickened by the deadly disease with more than 2,100 deaths, according to news reports. The bone and tissue eating fungus can attack the gastrointestinal tract, lungs, skin and the sinuses, where it often spreads to the eye socket and brain if left untreated. An uprise of covid cases is linked to the increase of this fungal disease as Dr. Dileep Mavalankar an epidemiologist states, "Mycormycosis will tail off and go back to baseline as the covid cases subside". [The New York Times]

June 21, 2021 — McDonald's begins offering free food at select Southern California locations for people who get covid shots. Would you like a vaccination with that? The fast food chain partners with the California Department of Health to offer shots at more than 70 of its locations across the state in addition to pop-up locations where no appointments or health insurance is required. [ABC 7]

The Lancet updates letter dubbing the 'covid' lab leak theory a 'conspiracy theory' by stating the possibility as it gains wider recognition. The letter acknowledges how one of the leading virologists, Peter Daszak, who signed the disputing statement that it originated in a lab had failed to disclose "competing interests" as required by the International Committee of Medical Journal Editors.

June 22, 2021 — Google has been funding virus research carried out by Wuhan-linked scientist Peter Daszak at EcoHealth Alliance for over a decade. Up until recently, people who voiced their concern that covid leaked from a lab were censored or banned by Google-owned YouTube. The financial ties were first reported by The National Pulse and disclosed various scientific studies dating back to at least 2010 such as the 2010 study on bat flaviviruses. Daszak credits in a 2015 paper **google.org** for funding on herpes. [Summit News]

Illegal Do Not Resuscitate, ventilators and involuntary euthanasia has risen during the covid pandemic with examples of "unprecedented" orders for those with learning disabilities. A man in his fifties with loss of sight was admitted into the hospital after chocking and diagnosed incorrectly with covid. He was issued a DNR form with the reason being his "blindness and severe learning disabilities". [Off Guardian]

June 23, 2021 — National Institute of Health confirms covid genetic sequence data taken from patients early 2020 in China was erased from the US archive database. The viral sequences were removed at the request of the scientist who submitted them. Virologist Jesse Bloom of the Fred Hutchinson Cancer Research Centre in Seattle said he recovered the sequences by a team from Wuhan University in January and February 2020. [SCMP]

Dr. Francis Christian, Clinical Professor of General Surgery at the University of Saskatchewan was suspended for all teaching responsibilities for voicing covid shot safety concerns. The Justice Centre for Constitutional Freedoms represents Christian in his defense of the complaint made against him. An investigation committee by the College of Physicians and Surgeons of Saskatchewan object to Dr. Christian having advocated for informed consent of shots for children. [Justice Centre]

Scientists working on the CDC's Advisory Committee on Immunization Practices (ACIP) said they would not recommend booster shots due to lack of evidence they are needed. Pfizer proceeds to make plans that keeps its billion dollar revenue stream going by assuring investors booster doses will be needed long after the pandemic.

"I would have to agree with the interpretation of the working group in the sense that there's no data to support recommendations to support boosters at this time," said Dr. Sharon Frey, a member of the ACIP and clinical director of the Center for Vaccine Development at Saint Louis University Medical School. "There's no evidence against declining protection at this time." [CHD]

June 25, 2021 — World Health Organization urges fully vaccinated people to continue wearing masks and obeying 'covid' regulations to protect against delta 'covid' variant. The instillation of fear and stress on an entire world population this organization claims to be looking out for continues as Dr. Mariangela Simao, WHO assistant director-general states, "People cannot feel safe just because they had the two doses. Vaccine alone won't stop community transmission". Simao is commenting on vaccines stopping

transmission despite no study existing that ever proved 'covid' shots prevented transmission.

This was recently admitted by senior Pfizer executive Janine Small during a testimony before the European Union Parliament on October 10, 2022 that Pfizer did not know whether its covid shots would prevent transmission.

[Off Guardian] Department of Veterans Affair Secretary Denis McDonough announces covid shots will be mandatory for Title 38 VA health care personnel, including physicians, dentists, podiatrists, optometrists, registered nurses, physician assistance, expanded-function dental auxiliaries and chiropractors who work in Veterans Health Administration facilities, visit VHA facilities or provide direct care.

June 29, 2021 — JAMA Cardiology Medical Journal publishes a study which shows U.S. military members with an average age of 25 years complained of chest pain within four days of receiving a 'covid' shot. The 23 patients studied had developed myocarditis after getting Pfizer BioNTech and Moderna jabs. As a result of what was being called a "rare incidence", U.S. health regulators added a warning to the accompanying literature of the mRNA shots to flag the risk of developing myocarditis in young men. [Reuters]

July 1, 2021 — Digital covid certificate apart of the European Union's free movement goes into effect. The initiative aimed at boosting their ailing

tourism industries causes friction over the number of shots that do not qualify. The European Union only lists four vaccines made by Pfizer-BioNTech, Moderna, Johnson & Johnson and AstraZeneca. This certificate therefore leaves out the international Covax mechanism that has already been distributed across Africa such as Covishield, a version of the AstraZeneca shot that was manufactured in India. Certificate holders would be able to show their vaccination status through a Q.R. code issued by their country of residence. [NYT]

July 4, 2021 — Three cases of the deadly black fungus disease, mucormycosis is recorded in Afghanistan resulting in one death at a hospital in Kabul, according to public health officials. The disease is noted as rare in the United Sates and Europe and is likely caused by unsanitary hospital conditions. Covid infections have apparently played a role in contracting the fungal disease as all three patients were 'covid' positive. In India, doctors are over prescribing steroids to aid covid patients who can't breathe which has lead to even more weakened immune system. It's believed the weakened immune systems were more likely to contract this deadly black fungus after taking steroids. [NYT]

July 5, 2021 — According to a new CDC study, an asymptomatic woman traveling from the U.S. back to her home in China, infected her downstairs neighbors when she used the same elevator. They believe transmission likely occurred when the neighbor touched surfaces and buttons in the shared apartment complex elevator. The woman quarantined in her apartment upon arrival back to China and avoided close contact with other apartment-building residents. An antibody test revealed she was an asymptomatic 'covid' carrier and three weeks later is when her downstairs neighbor and four other 'close contacts' also tested positive. Contact tracing revealed the neighbor was patient zero of a 71 person cluster in the local community. [Business Insider]

July 8, 2021 — Emma Burkey, a high school senior received one-shot Johnson & Johnson shot on April 1 and within two weeks she was placed in an induced coma. After undergoing three brain surgeries, experiencing seizures and developing blood clots in her brain, friends of the family turned to GoFundMe to raise money to cover the first round of medical bills amounting to \$513,000. It is unclear if Emma's medical costs will be covered by insurance, "Right now it feels like the national debt," a family spokesperson said. 'It's so big you can't get your head around it." [CHD]

July 9, 2021 — Dr. Joseph Mercola publishes an article that highlights how big Pharma wrote 10,000 checks worth \$9 million dollars to elect state

politicians in 2020. The top pharmaceutical lobbyist in the 2020 elections was Pharmaceutical Research and Manufacturers of America (phRMA) which spent \$25.9 million at the state and federal level. One year-long analysis by the Sunlight Foundation found that for every dollar spent influencing politicians, corporations received \$760 from the government. This is a 76,000% return on their investment. [CHD]

At the G20 meeting held in Venice, a panel of experts told finance ministers of 20 rich countries that governments need to find \$75 billion dollars over the next 5 years to prepare for future pandemics. "The economic case for these additional investments is overwhelming," said former U.S. Treasury Secretary Lawrence Summers, who co-chaired the 23-member panel along with World Trade Organization Chief Ngozi Okonjo-Iweala and Singapore's former finance minister, Tharman Shanmugaratnam. [Reuters]

July 11, 2021 — The unvaccinated 90 year-old woman who died in March 2021 in Belgium had allegedly caught two covid variants at the same time, presenting a double infection. Health experts believe it is the first documented case of its kind, although rare and similar dual infections do arise. The case would be discussed at the yearly European Congress on Clinical Microbiology and Infectious Diseases. The woman became sick with the Alpha and Beta types first identified in the UK and South Africa. [BBC]

July 12, 2021 — In an effort to head off rogue scientists conducting experiments with the human genome, a committee of experts working with the World Health Organization announce stronger limits on powerful human gene editing methods after two years of deliberation. "I am very supportive," said Dr. Leonard Zon, a gene therapy expert at Harvard University who was not a member of the committee, but called it a "thoughtful group." Recent gene-editing results are "impressive," he said, and the committee's recommendations will be "very important for therapy in the future." The guidelines were prompted by the case of He Jiankui, a scientist in China who used CRISPR technology to alter the DNA of human embryos. He Jiankui attempted the editing with a goal to alter DNA of babies so they were unable to contract H.I.V., however a court in China determined he forged ethics documents and misled subjects. [NYT]

French President, Emmanuel Macron states restrictions would be enforced on those who are not vaccinated for 'covid', prompting hundreds of thousands of people in France to set up 'covid' vax appointments. The president set a deadline stating health workers had to get inoculated by September 15 or face consequences which outraged some employees. Stanislas Niox-Chateau, who heads Doctolib, one of the country's biggest online websites used to

book vaccine appointments, told RMC radio there were record numbers seeking vaccines after the president's announcement. In nearly 24 hours, some 1.7 million vaccine appointments had been booked through Doctolib, the website said.

"Today you are 792,339 to have received a first jab, a new record. This drive must amplify and continue in coming weeks," Prime Minister Jean Castex said on Twitter. [Reuters]

The Food and Drug Administration announces the Johnson & Johnson covid shot may trigger a rare neurological condition in a small number of people who receive the drug. The agency said there have been about 100 preliminary reports of Guillan-Barre Syndrome from the shot. Most of the cases showed people developed the condition about two weeks after receiving the inoculation. Immunologist at Weill Cornell Medicine, John Moore noted most of the cases are in older males which fits the known pattern of GBS. [Stat News]

July 13, 2021 — Tennessee Health Commissioner Dr. Lisa Piercey ends vaccine outreach and school events amid pressure from Republican state lawmakers, according to an internal report and agency emails obtained by the Tennessean. The Tennessee Department of Health's decision will halt all adolescent vaccine outreach, not just for covid. The health department will also no longer send postcards or other notices reminding teenagers to get second jab of covid shots. Instead the postcards would be sent strictly to adults so they aren't "potentially interpreted as solicitation to minors", the report states.

Center's for Disease Control ties 'covid' vaccination to hurricane preparedness stating that inoculation is essential to weathering the storm. July 14, 2021 — Foo Fighters announce their upcoming Saturday concert in Los Angeles has been postponed indefinitely after one confirmed 'covid' within the Foo Fighters organization. The Foo Fighters noted in their announcement they have "made every effort to follow CDC covid protocols and local laws" as they returned to performing. USA Today's coverage of the

Fighters announcement broke down the current trend in alleged U.S. covid cases by reporting:

The nation is averaging about 25,300 new cases per day, more than double the 11,300 per day the week of June 22. The total rose in 48 states – all but Iowa and South Dakota, though the totals represent only about 10% of the numbers being reported in the worst week in January. Experts attribute the rise in cases to low vaccination rates, the relaxation of mask rules and other precautions, and the swift spread of the more-contagious delta variant.

Alleged Delta variant sweeps across poorly vaccinated populations in the U.S. according to a Guardian report. Infection rates in Kansas, Oklahoma, Missouri, Arkansas, Louisiana and Mississippi become the epicenter cluster of midwestern and souther states where the new variant has created 'covid' outbreaks. "We are not where we were in April 2020," said Dr David Dowdy, an associate professor of epidemiology at Johns Hopkins University and an expert in infectious diseases. Nevertheless, he said, "We've seen those counts can go up substantially and quickly, so we need to be cautious but without panicking." [The Guardian]

July 15, 2021 — Los Angeles County Public Health Officer Dr. Mantu Davis announces a reinstated mask mandate for all residents requiring they be worn in indoor public spaces starting 11:59pm on Saturday. The reason for the new mandates was based on the county's case rate per 100,000 people coming in at 7.1. These numbers put the region in the "Substantial" category of spread, according to the CDC.

"This is an all hands on deck moment. WE're seeing the rates go up too high. We all need to do our part to try and prevent the need to do something else", said Dr. Mantu Davis [Deadline]

Fort Rucker in Alabama becomes the first military base in the United States to require unmasked uniformed service members provide proof of covid vaccinations. Only 33 percent of the state's population is fully vaccinated which is one of the lowest in the country and cases have allegedly shot up 133 percent over the previous two weeks, according to a New York Times database. Hospitalizations have supposedly also rise 39 percent over two weeks.

"The big difference is going to be that if you are not wearing a mask, the leadership will be able to ask you, ask soldiers, to prove that they've been vaccinated by showing their vaccination card," said Major Get. David Francis,

the commanding general of Fort Rucker in a video posted on Fort Rucker's Facebook page. [NYT]

July 18, 2021 — U.S. District Judge Damon R. Leichty hands down a 101-page decision that said Indiana University can require 'covid' rejections and the establishment acted reasonably to protect public health. The mandate requires all students, faculty and staff to be fully vaccinated with limited medical and religious exemptions. The judge denied an injunction by eight college and graduated students who said the university's drug mandate was unconstitutional and infringed on their bodily autonomy and medical privacy. [The Wall Street Journal]

July 19, 2021 — Britain celebrates "Freedom Day" with Prime Minister Boris Johnson still confined in quarantined and tens of thousands forced back into quarantine after they were notified by the National Health Service's cellphone app that they had been in contact with an infected person. Despite nightclubs and pubs opening their doors to allow patrons to embrace each other, 39,950 positive covid cases were reported which caused major incongruities and confusion on the long-awaited liberation day. The U.S. State Department and CDC also issued their highest-level travel warnings for the UK, citing high levels of the 'virus'. [NYT]

Hollywood's major unions agree on a short term plan that would require all studios to mandate covid shots. The agreement would decrease the rate of regular covid testing and relax mask mandates in outdoor settings. The agreement made was by the Directors Guild of America. The International Brotherhood of teamsters,, the Screen Actors Guild-American Federation of Television and Radio Artists, along with studios represented by the Alliance of Motion Pictures and Television Producers. Four parents of children who planned to enroll at D.C. public and charter schools sue Mayor Muriel E. Bowser and other public officials over the law, the Minor Consent to Vaccinations Amendements Act that was passed in October. The parents said the law, "subverts the right and duty of parents to make informed decisions about whether their children should receive vaccinations". The lawsuit was filed in U.S. District Court for the District of Columbia which cited parents' religious objections to covid shots and other immunizations. [Seattle Times]

July 20, 2021 — The Chief Health Officer of New South Wales, Dr. Kerry Chant tells Australians at a press conference they shouldn't engage in a conversation with each other. "Whilst it's human nature to engage in conversation with others, to be friendly, unfortunately this is not the time to

do that", said Chant in response to people being ordered to comply with another lockdown. The new lockdown came after just a handful of new cases, which included a man who visited a supermarket, Pizza Hut restaurant, petrol station and office supplies store. [Summit News]

July 21, 2021 — U.S. Centers for Disease Control and Prevention announces it will be withdrawing its request for emergency use authorization for its 'covid' PCR diagnostic test after December 2021. CDC claims the performance of their RT-PCR test for detecting 'covid' didn't fail, but that better tests have since become available. [News Wise]

Former NIH scientist and immunologist, J. Bart Classen analyzed data on 'covid' shot adverse reactions and found thousands of reports to the UK's Yellow Card system that showed clear signals of neurodegenerative disorders induced by the shots. White House coronavirus response coordinator Jeff Zients tells reporters the country has "fundamentally change the course of this pandemic" and the treat of serious disease and death now is to the unvaccinated.

"This week, just three states Florida, Texas and Missouri, three states with lower vaccination rates accounted for 40 percent of all cases nationwide," Zients said at a White House news conference. "For the second week in a row, one in five of all cases occurring in Florida alone. And within communities, these cases are primarily among unvaccinated people." [CNN]

July 24, 2021 — Protests rage across Europe over the mandatory use of a public health pass called by the French government, in Marseille. Thousands upon thousands of protestors erupted across Europe in London, Dublin, Paris, Rome, Athens and other cities against the health pass and other 'covid' restrictions such as mandatory lockdowns and vaccines. Tear gas was fired by police at demonstrators at Champs-Elysees thoroughfare. Leaked Pfizer documents reveal contracts with governments that includes making them pay for covid shots whether they worked or not. The

July 30, 2021 — Seventy four percent of covid cases in a Cape Cod outbreak were among vaccinated people, making up three-quarters of the breakthrough cases. Researchers claim most of the positive cases were from the delta variant and linked to multiple summer events and large summer gatherings in a small town. Almost 80 percent of the positive cases were symptomatic, according to Catherine Brown, DVM, of the Massachusetts Department of Public Health. [MedPage Today]

Scientists who studied a big 'covid' outbreak in Massachusetts found that vaccinated individuals carried just as much of the virus as unvaccinated. Individuals can offer proof of their vaccination status using the city's COVID safe app, the state's Excelsior app or the Center for Disease Control and Prevention paper card issued at vaccination sites. "If you don't get vaccinated, you're going to get left out of a lot of things," the mayor said. [Gothamist]

August 5, 2021 — Governor David Ige of Honolulu announces at a news conference that all state and county workers in Hawaii will need to provide

proof of vaccination by August 16th or be subject to mandatory weekly testing at their own cost. If they do not comply they could be fired under these new vaccine requirements. "The number of cases and hospitalizations are all trending up dramatically," said Gov. David Ige. "The highly contagious delta variant creates a big risk of infection." [Hawaii News Now]

New York State Health Commissioner Dr. Howard Zucker announces the governor's office and state Department of Health will not provide health guidance to school districts in the fall. The guidance will instead be left up to local districts to make decisions on masking, surveillance testing and social distancing. The choice to hand over covid mitigation protocols was based on guidance from the CDC. "With the end of the state disaster emergency on June 25, 2021, school districts are reestablished as the controlling entity for schools," Zucker said. "Schools and school districts should develop plans to open in-person in the fall as safely as possible, and I recommend following guidance from the CDC and local health departments." [Times Union]

August 6, 2021 — Former New York Times reporter, Alex Berenson publishes on his substack "Unreported Truth," that covid vax maker, Moderna received 300,000 reports of side effects over a three-month period following the launch of its shot. The figure is far higher than the number of side effects made publicly available in the VAERS federal system that tracks adverse events. Moderna is legally required to forward all side effect reports received to the Vaccine Adverse Events Reporting System.

Denmark's SSI infectious diseases agency said it no longer relied on vaccination to achieve herd immunity in the country. Tyra Grove Krause, the SSI's acting academic director, said a new wave of infections were expected after people return to work and school at the end of this summer, but it should not be cause for alarm. August 11, 2021 — The Centers for Disease Control and Prevention urges all pregnant women to get experimental covid shot based on a study that showed no increase of miscarriage risks. A small study of 2,500 women allegedly showed no increase of miscarriage for those who received at least one dose of the Pfizer or Moderna shot before 20 weeks of pregnancy. CDC states expectant women who are unjabbed run a higher risk of severe illness and pregnancy complications for contracting the virus. "The vaccines are safe and effective, and it has never been more urgent to increase vaccinations as we face the highly transmissible Delta variant and see severe outcomes from covid among unvaccinated pregnant people," CDC Director Dr. Rochelle Walensky said in a statement. August 12, 2021 — Researchers in the U.S. find that children born during the coronavirus pandemic have significantly reduced IQs — reduced verbal, motor and overall cognitive performance coupled with children before. The study acknowledges the first few years of a child's life are critical to their cognitive development and with covid triggering the closure of businesses, nurseries, schools and playgrounds, life for a child's development has considerably changed. Sean Deoni, a lead study author and associate professor of pediatrics (research) at Brown University said that with limited stimulation at home and less interaction with the world outside, pandemicera children appear to have scored shockingly low on tests designed to assess cognitive development. The Food and Drug Administration authorize a third dose of Pfizer-BioNTech's and Moderna's covid vaccines for immune compromised people. FDA approves the third shot a day before the CDC's independent advisory committee was set to consider and vote on whether or not to even recommend the additional dose. The authorization updates the current emergency use authorizations for the two shots and applies to people who received solid organ transplants and others with weakened immune systems. "The F.D.A. is especially cognizant that immunocompromised people are particularly at risk for severe disease," Dr. Janet Woodcock, the acting F.D.A. commissioner, said in a statement. "After a thorough review of the available

data, the F.D.A. determined that this small, vulnerable group may benefit from a third dose of the Pfizer-BioNTech or Moderna Vaccines." [NYT]

August 13, 2021 — Hawaii Attorney Michael Green files a Class Action Lawsuit representing 12,000 first responders who risk termination if they do not comply to the Governor and Mayor's new vaccine mandate for all state workers and county workers in Hawaii. Michael Green says the drug shot has killed almost 45,000 people within 72 hours of inoculation according to data compiled around the country and the new mandates are absolutely criminal and unnecessary. Honolulu Fire Captain Kaimi Pelekai of 20 years, provides an emotional testimony about losing his job because he does not want to put an experimental vaccine in his body that is killing people. August 16, 2021 — New York Governor Andrew M. Cuomo announces all healthcare workers in the state, including staff at hospitals and long-term facilities (LTCF), nursing homes, adult care and other congregate care settings must be vaccinated against 'covid' by September 27.

August 17, 2021 — Actress Sally Kirkland, 79, announces she has never experienced this level of pain after receiving the Moderna vaccine. Kirkland says she was healthy before the shot and signed up to receive the jab after witnessing how sick her friend was when she allegedly contracted 'covid'. In an episode of "The People's Testaments," Kirkland told Polly Tommey, "Like I know my own name, I would advice you not to do the vaccine." Sally also mentions that some doctors refused to blame the shot for her adverse reaction symptoms, despite the obvious onset of symptoms post vaccination. [CHD]

August 18, 2021 — A repurposed concert hall in Australia was used to vaccinate thousands of students ahead of in-person end-of school exams. Due to the worsening outbreak of the highly infectious Delta variant, health officials in Australia are rushing to vaccinate students with the 40,000 shots

developed by Pfizer Inc. and BioNTech SE that were developed for rural towns and diverted to students in covid hotspot Sydney suburbs. August 19, 2021 — Facebook calls out The Center for Countering Digital Hate (CCDH) for not having "any evidence" against 12 individuals who have been defamed and labeled as the "disinformation dozen". After allowing months of accusations against 12 "super spreaders of misinformation" on its platform, Facebook alleges CCDH's report titled, The Disinformation Dozen: Why platforms use act on twelve leading online anti-vaxxers is a false narrative. The CCDH's report has been a driving force in a global campaign to target and deplatform outspoken health freedom and informed choice advocates. [Green Med Info]

While 90 percent of U.S. parents plan to send their children back to school, fewer than 60 percent plan to get their eligible children vaccinated before school begins. Anxiety over the shots safety and efficacy continues to prompt hesitancy for parents on decision to inoculate despite the alleged highly contagious Delta variant spreading nationwide. [Health Day]

August 20, 2021 — As the debate over issuing covid booster begins to heat up, the CDC releases VAERS data showing a total of 592,622 reports of adverse events from all age groups following the covid shots, including 13,068 deaths and 81,050 serious injuries between December 14, 2020 and August 13, 2021. These reports are an increase of 702 over the previous week and excludes "foreign reports" filed in VAERS. The protests are a result of horrific video footage over the previous week that surfaced online of Australian police beating up 12 year-olds for not wearing masks and ripping a child from a parent's arms who allegedly wouldn't inject her with 'covid' shot. August 22, 2021 — Australian truck drivers warn citizens to stock up on food and basic necessities as they prepare to take the country back from tyrannical dictators. Video messages surface across alternative social media sites stating the road blockades will disrupt the supply chain and demand industrial action. The Transport Workers Union (TWU) announced the strike comes after "crisis talks" over a new enterprise bargaining agreement with Toll collapsed.

Alan Beacham, head of Toll subsidiary Global Express, said he was disappointed that the union would go on strike during the coronavirus pandemic. "Threatening industrial action at a time when our country is in the middle of a global pandemic is playing politics with people's lives and jobs. TWU national secretary, Michael Kaine however accused Toll of seeking to follow the lead of Qantas which contracted out more than 2,000 ground crew jobs. "Toll workers need guarantees that they won't be sliced and diced



Qantas-style and replaced by a cut-price, underemployed workforce," Mr Kaine said. [ABC AU]

Montana passes a law that bans vaccine requirements for all employees and prohibits businesses providing goods and services to discriminate against customers based on vaccine status. The Montana Hospital Association opposed the law warning it could be harder for the state to meet medical services since healthcare workers maybe deterred from working in 'unsafe' hospital settings. Although, a plethora of scientists and physicians disagree with the idea of mandating, arguing the measures would discourage people even more from getting and inoculated and ignores the science of natural immunity. August 23, 2021 — The U.S. Food and Drug Administration grants full approval to the Pfizer/BioNTech covid shot for people 16 years and older, marking the first covid vaccine to be approved by the FDA. The decision was made despite no public discussion or formal advisory committee meeting held to discuss data. The approval would allow for more covid shot mandates by employers and universities. "For businesses and universities that have been thinking about putting vaccine requirements in place in order to create safer spaces for people to work and learn, I think this move from the FDA,

when it comes, will actually help them to move forward with those kinds of plans," U.S. Surgeon General Dr. Vivek Murthy told CNN's Brianna Keiler.

FDA publishes a news release approving the first 'covid' shot for individuals 16 years of age and older, but switches the legal name. The shot that was known before as Pfizer-BioNTech now is marketed as "Comirnaty". The FDA claims the two shots can be used interchangeably. Under Emergency Use Authorization the vaccine continues to be available for individuals 12 through 15 years of age.

"The FDA's approval of this vaccine is a milestone as we continue to battle the COVID-19 pandemic. While this and other vaccines have met the FDA's rigorous, scientific standards for emergency use authorization, as the first FDA-approved COVID-19 vaccine, the public can be very confident that this vaccine meets the high standards for safety, effectiveness, and manufacturing quality the FDA requires of an approved product," said Acting FDA Commissioner Janet Woodcock, M.D. "While millions of people have already safely received COVID-19 vaccines, we recognize that for some, the FDA approval of a vaccine may now instill additional confidence to get vaccinated. Today's milestone puts us one step closer to altering the course of this pandemic in the U.S." [FDA]

August 24, 2021 — Pfizer CEO Albert Bourla acknowledges there will be future covid variants that will be resistant to current vaccines on the market. "Every time that the variant appears in the world, our scientists are getting their hands around it," Bourla told Fox News in an interview. "They are researching to see if this variant can escape the protection of our vaccine. We haven't identified any yet, but we believe that it is likely that one day, one of them will emerge." While stating he was "quite confident" Pfizer vaccine could neutralize new mutations based on encouraging lab results he also raised the "fundamental question" of how likely it is a variant will emerge that is vaccine-resistant.

"Theoretically, it's a very possible scenario. If you protect a very big part of the population, and if there is a strain that emerges that can use this pool of population to replicate while the current strains cannot, obviously this will overtake the original. So it's not a certainty, but it is now, I believe, a likely scenario," he said. [The Epoch Times]

A 15 year-old girl was allegedly forced to wear an ankle 'covid' tracking monitor for volleyball practice at Eatonville High School in Washington state in order to participate in team sports. The device was developed by a

company called Triax that according to their website was created for the purpose of "maintaining social distancing guidelines" and to provide "real-time insight into whether these guidelines are being observed" for construction and other manufacturing businesses, but the school does not mention it on their website. The devices provide "...a visual and audible alarm, so individuals know when to adjust their current distance to a proper social distance." Additionally, the monitors provide "Passive collection of worker interactions for contact tracing should an individual test positive." [The Post Millennial]

August 25, 2021 — New York City's largest police union told its member that it would sue if cops are required to get the covid shot. 'If the City attempts to impose a vaccine mandate on PBA members, we will take legal action to defend our members' right to make such personal medical decisions," Police Benevolent Association President Patrick Lynch wrote in an email. The statement comes after Mayor Bill de Blasio announced a covid shot requirement for all New York City school staffers.

In Chicago, Mayor Lori Lightfoot also imposed a vaccine mandate deadline of October 15 for all city employees despite a united opposition from all four police unions.

"As cases continue to rise, we must take every step necessary and at our disposal to keep everyone in our city safe and healthy," Lightfoot was quoted as saying in a press release.

"This has literally lit a bomb underneath the membership," said Fraternal Order of Police President John Catanzara. "We're in America, Goddamn it. We don't want to be forced to do anything. Period. This ain't Nazi fucking Germany."

Over one thousand people protest in the streets of New York City outside City Hall against covid vaccine mandates, chanting "we will not comply" and "no more shots". Teachers were on the frontline organized by New York Unions after Mayor Bill de Blasio announced public school teachers and staff must be vaccinated. "They're using us as lab rats," said city employee Kim Williams, of Queens. "We don't have the long-term side effects or risks yet." One parent said. [CBS]

Unvaccinated Delta Air Lines staff is ordered to pay \$200 monthly health insurance surcharge for their company-sponsored health care plan, according to company's top Chief Executive Officer Ed Bastian. The executive

wrote in an August 25 memo the extra charge would take effect of November 1 and comes in response to the high cost of staff hospitalized for covid. "The average hospital stay for COVID-19 has cost Delta \$50,000 per person," Bastian wrote. "This surcharge will be necessary to address the financial risk the decision to not vaccinate is creating for our company." [The Epoch Times]

August 26, 2021 — New York State Department of Health board votes unanimously to impose a 'covid' shot mandate for all health care workers in the state while removing religious exemptions as an alternative. Vanessa Murphy, a DOH attorney states that, "We're not constitutionally required to provide a religious exemption. You see that with the Measles and the Mumps requirement for health care workers." [Record Online]

Lisa Shaw, a 44 year-old radio presenter for BBC Radio Newcastle was officially found to have died from complications to the AstraZeneca Covid shot. Newcastle coroner Karen Dilks says, "Lisa died due to complications of an AstraZeneca Vaccine that induced thrombotic thrombocytopenia." After her first dose of the shot on April 29, 2021, she complained of a "severe headache shooting and stabbing" across her forehead behind her eyes for several days. On May 13 Lisa was taken to the University Hospital of North Durham where tests revealed blood clots in her brain. Shaw suffered a haemorrhage in the brain and the condition worsened despite surgery and treatments. She died on May 21st. [BBC]

Japan suspends 1.63 million doses of Moderna's covid vaccine as a precaution after the domestic distributer received reports of contaminants in some vials. Japan's Takeda Pharmaceutical company admit they first heard about the possible contamination on August 16, but did not report it until two days later because Takeda needed time to gather information on which vials were affected. "The company is investigations the reports and remains committed to working expeditiously with its partner, Takeda, and regulators to address this," said the U.S. vaccine maker, Moderna in a statement. Rensselaer County's chief medical examiner, Dr. Michael Sikirica refuses to get 'covid' vaccinated, forcing the county to send bodies for autopsies to Glen Falls Hospital instead of Albany Medical Center Hospital. Albany Medical Center requires everyone providing service on campus be vaccinated. "Dr. Sikirica is not employed by Albany Med, but consistent with our policy, physicians who do provide services on our campus must be vaccinated," said Matt Markham, vice president for communications for the hospital. Sikirica is known as the Capital Region's best-known pathologist who is relied upon by area district attorneys as an expert witness at murder trials to describe how homicide victims were killed. [Times Union]

October 3, 2021 — Israel updates 'covid' green pass terms to allow only those who received booster jabs or recently recovered from 'covid' can enter indoor venues. The new updates effect nearly 2 million people with existing vaccination passports. The country becomes the first to require booster jabs as a requirement for its digital vaccination passport in an effort to persuade more people get a third shot. [ABC AU]

October 4, 2021 — Johnson and Johnson plans to seek federal regulators' approval of a 'covid' booster shot after federal officials claim their single dose jab doesn't offer enough protection. The firm is the last of the three federally authorized vaccine providers that call for extra injections to protect high-risk groups and elderly. CDC study claims Johnson & Johnson's single-dose vaccine was only 71 percent effective against hospitalization from Covid-19, compared with 88 percent for Pfizer-BioNTech's vaccine and 93 percent for Moderna's. "Although these real-world data suggest some variation in levels of protection by vaccine, all FDA-approved or authorized COVID-19 vaccines provide substantial protection against COVID-19 hospitalization," researchers concluded. College students withdraw from schools that are enforcing covid vaccine mandates stating the covid shot is not a price they are willing to pay for a degree. Justin Mishler, a 29-year old junior at Northern Illinois University

enrolled in the state school through the GI Bill after serving in the U.S. Marine Corps and refuses to get vaccinated. "I was excited but when I saw you had to be vaccinated, I decided to keep working instead," he said. [CNBC]

California Physician, Dr. Houman Hemmati sounds alarm on Governor Gavin Newson's new vaccine mandate targeting vaccine eligible school-age children saying his decision was "not based on clinical evidence" but fueled by politics. As a physician, the one thing that I'm taught, the one thing that we should all practice is evidence-based medicine, and the evidence-based decisions need to not just extend to the doctor-patient relationship, but also to policies that are made by politicians and public health boards", said Dr. Hemmati on Fox & Friends First. Golden State Warriors guard, Andrew Wiggins receives 'covid' shot after NBA denied him a religious exemption. During media ay Wiggins' was getting numerous questions about his vaccination status and reasons for refusing the shots. "I'm just going to keep all that private right now. ... Anything that has to do with my status, vaccination, I'm going to keep it personal, private. Back is definitely against the wall. I'm gonna keep fighting for what I believe. What's right to one person isn't right to the other and vice versa," said Wiggins. [FOX]

Roughly 43,000 doses of covid shots have been administered since New York City announced its fear tactic campaign in August to enforce mandates or face termination from work. Eighteen thousand shots were give to Department of Education staff members since September 24, 2021 in order to meet inoculation deadline. "These mandates work, and we're going to consider in the days ahead what else makes sense to do," Mr. de Blasio said during a news conference on Monday, when asked about mandating vaccines for other city workers. A Senior New York Associate Court of Appeals Judge, Jenny Rivera, is the only state jurist who has declined the covid shot and application for a medical or religious waiver. Judge Rivera is barred from entering any court facilities, including her chambers. Rivera is the sole jurist who will tune into the monthly panel session remotely to hear oral arguments in an Albany courthouse. "Currently, there is only one state-paid judge statewide out of compliance with our vaccine mandate policies," said Unified Court System spokesman Lucian Chalfen. "If it works for her and she can participate remotely, I don't see the problem," said state Court of Appeals spokesman Gary Spencer, who declined to comment on her vaccination status. "We do

not discuss the personal health information of anyone — judges or staff." [NY Post]

Editor's Note: So, paid state workers of the judiciary branch are able to work remotely, but other city workers like teachers and law enforcement are fired for refusing experimental drug shots? This seems biased and ironic considering how judges are entrusted with upholding the law of the land and the judiciary branch in this case has chosen "not to discuss health status" while allowing the state to fire city workers over their medical choices. — mmd

Project Veritas releases fourth video of its covid investigative series that exposes three Pfizer officials, Nick Karl, Chris Croce and Rahul Khandke, saying natural antibodies offer equal or better protection against the alleged virus than drug shots. Nick Karl is one of the scientists who works in the production of Pfizer's covid shot. "When somebody is naturally immune -- like they got COVID -- they probably have more antibodies against the virus...When you actually get the virus, you're going to start producing antibodies against multiple pieces of the virus...So, your antibodies are probably better at that point than the [COVID] vaccination," Karl said. The company states it worked with the U.S. Food and Drug Administration to remove the affected tests from market. Ellume claims it has isolated the cause and confirmed the false positive came from specific lot numbers. When asked about the recall, an Ellume spokesperson said, "The increase in false positives was the result of a supply chain issue with one of the test components. Because of the proprietary information involved in the manufacturing process, we cannot offer more specifics." [WAVY]

Victorian casual relief teacher Belinda Cetnar and her husband Jack sue state of Victoria over mandatory covid vaccines, arguing there is no legal or ethical justification for mandating workers get jabbed with experimental drugs "The proposed directives to mandate Covid-19 vaccines for school or childcare staff is not a proportionate response to the Covid-19 pandemic in circumstances where there is a 99.9% survival rate and children mostly suffer mild effects from the disease," Belinda Center said in court documents.

United Airlines (UAL) begins firing unvaccinated U.S. based worker, but agrees to postpone plans to put unvaccinated workers who applied for medical or religious exemptions on mostly unpaid leave. Six of the exempted workers challenge the UAL policy in a federal class action lawsuit filed in Texas. "You can have a mandatory vaccination policy; however, employees may be entitled to a reasonable accommodation based on either a sincerely held religious belief and or a disability, if it doesn't cause an undue burden on the employer," LaKeisha Caton, an attorney with Pryor Cashman, told Yahoo Finance. October 6, 2021 — UC Health hospital in Colorado refuses transplant surgeries for unvaccinated patients. Jamie Fougner, who is donating a kidney to Leilani Lutali states she hasn't received the vaccine for religious reasons and because there are too many unknowns pertaining to the experimental drug. The women met in bible study and didn't know about the vaccine mandate for donors until just before the surgery. "At the end of August, they confirmed that there was no COVID shot needed at that time," Lutali told CBS Denver. "Fast forward to September 28. That's when I found out. Jamie learned they have this policy around the COVID shot for both for the donor and the recipient." UCHealth sent a letter informing the women if they don't comply with the shot mandate they will be taken off the transplant list. [CBS]

Denmark and Sweden halt the mass inoculation campaign of Moderna's mRNA 'covid' shot after recent data points to an increase inflammation of the heart muscle and pericardium. "The connection is especially clear when it comes to Moderna's vaccine Spikevax, especially after the second dose," Sweden's health agency said in a statement. It added that "the risk of being affected is very small." In Sweden, the pause affects people born 1991 or later and in Denmark, all people under 18 would not get the Moderna shot anymore, the country's health agency announced. Those who have already had their first Moderna shot will not get a second jab by the same maker.

"Discussions are ongoing about the best solution for this group," the Swedish health agency said. [Politico]

Researchers and scientists claim the covid virus maybe harming vital cells in the pancreas, leaving people with diabetes. As the pandemic has progressed, a growing number of reports of people who caught covid were also developing diabetic symptoms for the first time. "Clearly there's a link, there's some sort of mechanism that makes the diseases fuel one another," Francesco Rubino chair of metabolic surgery at King's College London, told Insider. "The question is whether new-onset diabetes could be caused by this virus." [Yahoo]

Merck asks Food and Drug Administration to grant emergency use authorization to its experimental covid anti-viral pill named molnupiravir that allegedly cuts hospitalizations and deaths by about half in early trials. Merck and its partner Ridgeback Biotherapeutics said Monday in a news release that, in addition to their FDA application, they plan to apply for emergency use or marketing authorization in other countries "in the coming months." Department of Homeland Security works with reachers and New York City agencies to deploy an allegedly non-toxic fas at about 120 locations across the city, including transit. Most of the locations will be above ground, but a number will be below-ground in subway stations. The tests were set on five separate days. Between Oct. 18 and 29. The study will track movement of non-toxic material and the results from these tests will be used to learn more about the relationship between airflow in street level and underground environments," the MTA said. October 13, 2021 — China prepares to test tens of thousands of blood bank samples from Wuhan city as part of a probe into 'covid' origins. World Health Organization's panel of investigators say the store of up to 200,000 samples in the Wuhan Blood Centers, including those from closing months of 2019, could provide a possible source of key information into covid origins. "This provides the closest in the world we've seen of real time samples to help us understand the timing of the outbreak event," said Yanzhong Huang, senior fellow for global health at the Council on Foreign Relations. October 14, 2021 — Abbott Molecular, Inc. recalls Alinity m SARS-CoV-2 AMP kit and Alinity m Resp-4-Plex AMP kit for potential false positive SARS-CoV-2 test results. The FDA has identified this as a Class 1 recall which is the most serious style. The decision of severity comes a month after Abbott issued a safety notice describing a defect that could cause some of its 'covid' tests to return false positive results. Abbott is September notified its healthcare provider and laboratory customer that it had identified issue with the software. The software automates the mixing of chemicals with the patient samples. Under certain mixing parameters, enough liquid may be added to a sample to cause it to overflow into neighboring wells in the processing tray. That could result in mistakenly positive results if a COVID-positive sample overflows into a nearby negative one. [Fierce Biotech] [FDA]

October 15, 2021 — 'Covid' testing at the Wolverhampton Lan has been suspended following an investigation by NHS Test and Trace for false results. About 43,000 people in England and Wales are reported to have been affected by the false results. Head of the UK Health Security Agency orders an investigation into why it took a month to identify the failures. Jenny Harries, chief executive of the UK Health Security Agency (UKHSA) and head of NHS Test and Trace, said it was "not clear" what went wrong. "We are

doing a detailed investigation with them, working on the actual processes within the laboratory - but the important thing of course is that we have suspended all of their services." she said. BBC admits in an article PCR tests and Lateral flow tests (LFTs) are expected to have false positive or negatives given no test is 100 percent perfect. [BBC]

October 18, 2021 — Former Secretary of State Colin Powell, dies at age 84 due to 'covid' complications, according to a statement made on the General Colin L. Powell Facebook page. The family stated the former Chiron of the Joint Chiefs of Staff had been fully vaccinated. Powell had been diagnosed with multiple myeloma, a type of cancer. "General Colin L. Powell, former U.S. Secretary of State and Chairman of the Joint Chiefs of Staff, passed away this morning due to complications from Covid 19. He was fully vaccinated. We want to thank the medical staff at Walter Reed National Medical Center for their caring treatment," the Powell family said in a statement posted to Facebook. [The Hill]

October 21, 2021 — Podcaster and comedian, Joe Rogan accuses CNN of lying about his use of ivermectin during his recovery from 'covid" as the network repeatedly describes the treatment as a "horse dewormer" and a "livestock drug". Despite the drug being prescribed to him in its human form by a doctor, Don Lemon of CNN calls Rogan a dangerous conspiracy theorist taking a veterinary medicine while speaking with Dr. Sanjay Gupta. A letter signed by the group states: "We are aware that the state of Israel is perceived as 'the world laboratory' regarding the safety and efficacy of the Pfizer-BioNTech COVID-19 vaccine, as reflected by statements made by Dr. Albert Bourla, Dr. Anthony Fauci, and other senior figures in leading health authorities throughout the world," the letter reads. "It is therefore our understanding that the data and information coming from Israel play a crucial role in critical decision-making processes in regards to COVID-19 vaccination policies. New York City's largest police union, The Police Benevolent Association (PBA) feels lawsuit in Staten Island Supreme Court to overturn the covid shot mandate for its members. The lawsuit came as a result of Mayor Bill de Blasio's announcement that would require all city workers be vaccinated by October 29, 2021 or face unpaid leave or terminated. The mandate provides no option to undergo weekly covid testing. The PBA states: "The Vaccine Mandate will impose irreparable harm on police officers. A police officer with sincerely held medical, health, or religious concerns with the vaccine will face irreparable harm if forced to submit to vaccination prior to the Court's

determination whether a the Vaccine Mandate is unlawful," the lawsuit states. "These officers have rights to medical autonomy and religious observance that would be violated by forcing them to submit to a vaccination. Once a vaccination occurs, that bell cannot be un-rung." [FOX News]

Eastern Washington Federal Judge Thomas Rice denies a bid by firefighters, state troopers and other state workers that would halt Washington's covid vaccine mandate for state workers and emergency responders. The group of workers sued Gov. Jay Inslee, Spokane Fire Chief Brian Schaeffer, Washington State Patrol Chief John Batiste and others saying their civil rights are being violated by vaccine requirement in order to keep their jobs. In his ruling, Rice wrote: "The Supreme Court has long endorsed state and local government authority to impose compulsory vaccines... Federal courts have routinely analyzed such cases using rational basis and regularly reject cases similar to this one that challenge vaccine mandates based on free exercise of religion." [AP News]

Rutgers University tells all employees from tenured professors to dining hall workers they must be 'fully-vaccinated' by December 8, 2021 or risk being fire from their jobs. Rutgers Chief Operating Officer, Antonio Calcado states, "President Biden's executive order supersedes other state or local rules, regulations, laws or executive orders. It does not allow for a regular testing option for those employees who choose not to be vaccinated." Calcado says he contracted 'covid' in February 2020 and was so sick he thought he was going to die. The decision comes after court Rutgers science professors started a petition in August stating that teachers and staff should be included in vaccine mandate despite 97 percent of professors already being vaccinated. "It was only universal vaccination that got rid of polio, smallpox, etc., and I believe only universal vaccination will get rid of COVID," said Troy Shinbrot, a biomedical engineering professor who wrote the petition, and is also a member of the Rutgers faculty union. "It is bizarre to imagine that requiring vaccinations of one group (students), but not others (e.g. faculty), will make Rutgers safe." [Patch]

Editor's Note: As of today, December 4, 2022, Rutger's University continues to enforce their mandatory covid vaccination policy in addition to booster jab mandates for eligible people. The University is one of the strictest in the country despite other Universities dropping the mandates and people getting sick from inoculation and dying from adverse reactions. — *mmd*

October 26, 2021 — A group of unvaccinated Maine workers ask the Supreme Court to block a state rule that violates the Constitution and Title VII, a federal civil rights law that bars employment discrimination based on religion by mandating covid shots. "Even in times of a crisis – perhaps especially in times of crisis-we have a duty to hold governments to the Constitution," Justice Neil Gorsuch wrote at one point. [CNN]

October 28, 2021 — Florida state sues President Biden, NASA and other agencies within the Biden administration of the unlawful 'covid' vaccine mandate that requires government contractors to get inoculated. "Even though the chances of [a child] getting sick and seriously ill are small — why do you want to take a chance of that with your child, when you can essentially protect the child by an intervention that is proven to be both highly effective and very safe?" he asked. [The Hill]

A cheap, generically available anti-depressant drug known as fluvoxmine can affect inflammation and therefore reduce the risk of severe covid illness, said Dr. Angela Reiersen, an associate professor of psychiatry at Washington University in St. Louis who worked on the study, published in The Lancet Global Health. Despite the drug being most often used to treat obsessive compulsive disorder (OCD) and depression, Reiersen claims, "Fluvoxamine may reduce the production of inflammatory molecules called cytokines, that can be triggered by SARS-CoV-2 infection." October 29, 2021 — A federal appeals court upheld the religious-exemption ban pertaining to New York's 'covid' vaccine mandate for medical workers. The U.S. Second Court of Appeals ruling allows the enforcement of 'covid' shots despite workers claiming religious exemptions. Hochul noted she "pledged as governor to battle this pandemic and take bold action to protect the health of all New Yorkers. "I commend the Second Circuit's findings affirming our first-in-the-nation vaccine mandate, and I will continue to do everything in my power to keep New Yorkers safe," she added in a statement. Twelve thousand Air Fore personnel refuse to get inoculated for 'covid' despite warnings from officials that threatened to punish them with possible dismissal from service or receiving a charge from the military justice system. Airmen who are close to leaving military may receive exemptions from the jab, but those who leave the military over vaccine mandate may have problems if they want to transition to federal government employees or government contractors in the future. "The fact that it's a choice leading to potential loss to readiness is striking," Katherine L. Kuzminski, a military policy expert at the Washington think tank Center for a New American Security, told The Hill. [The Hill]

Top finance and health ministers from the world's 20 biggest economies (G20) announced they would take steps to ensure 70 percent of the world population is inoculated against 'covid' by mid 2022. "To help advance toward the global goals of vaccinating at least 40 percent of the population in all countries by the end of 2021 and 70 percent by mid-2022 ... we will take steps to help boost the supply of vaccines and essential medical products and inputs in developing countries and remove relevant supply and financing constraints," the G20 ministers said in a statement. October Summary — Editor's Note: Hundreds of lawsuits are filed all over the United States and worldwide over vaccine mandates that pose serious threats to human rights. the lower the excess mortality. However, the opposite is the case and this urgently needs to be clarified. Excess mortality can be observed in all 16 [states]. The number of Covid deaths reported by the RKI in the period under consideration consistently represents only a relatively small part of mortality and, above all, cannot explain the critical facts:" [Expose News]

New York City Mayor Bill de Blasio announces a new mandate for children ages 5 to 11 requiring them to show proof of vaccination in order to enter restaurants, gyms, theaters and other places. Maribel is concerned for her son's health considering he has problems with asthma and allergies. Kathrin Jansen, Pfizer's head of vaccine research, said on a conference call with investors Friday that data on variants, including omicron, suggest that people vaccinated with three doses of the vaccine may have a higher degree of protection than those with two doses. "Therefore, we have decided to modify each of the pediatric studies to incorporate a third dose to the series and seek licensure for a three-dose series rather than a two-dose series as originally anticipated," Jansen said. December 20, 2021 — New Zealand authorities say 26 year-old man's death has been linked to heart inflammation side effects from Pfizer's 'covid' injection. Rory James Nairn died 12 days after his first 'covid' shot to myocarditis. "With the current available information, the board has considered that the myocarditis was probably due to vaccination in this individual," a COVID-19 Vaccine Independent Safety Monitoring Board said in a statement.
